Whereas it is necessary in the interest of public safety and convenience in view of the traffic blockade for laying of sewerage pipe line at four (04) places along M.L. Gupta Road i.e. (i) at the junction of Bhuban Mohan Roy Road, (ii) at the junction of Sodepur 1st Lane and Sodepur Brickfield Road, (iii) at the junction of Hemchandra Mukherjee Road and (iv) at the junction of Kalipada Mukherjee Road near Nilkanta Marriage Hall, I, Manoj Kumar Verma, IPS, Commissioner of Police, Kolkata, in exercise of powers vested in me under section 115, 116, 117, 122 and 126 of M.V. Act, 1988, Section 62, 62(1B) of Calcutta Police Act 1866, 39, 39(1B) of Calcutta Suburban Police Act 1866 read with rule no. 85, 86, 87, 88 and 93 of the Rules for the Regulation of Traffic in Kolkata and its Suburbs and under sub-section (1) of Section 4 of the West Bengal traffic regulation Act, 1965 (W.B. Act XV of 1965) read with Govt. of West Bengal Home (Transport) Depts. Order no. 7605-WT, Dated- 20th July 1965 and Govt. of West Bengal in Transport Depts. Notification No. 3363-WT/3M/34/99, dated- the 29th April, 1999 do hereby order that vehicular circulation pattern for the closure of Motilal Gupta Road, will be regulated / diverted in the following manner:

Circulation Plan:

Big vehicles like MGV, HGV including buses (Route no.'s S31, AC31, 21, SD4/1, Sarada Park – Anandapur Mini Bus), those intend to reach Sakherbazaar crossing on D.H. Road, from Muchipara crossing will avail Raja Ram Mohan Roy Road (West bound) – Chowrasta / James Long Sarani crossing – Biren Roy Road (East) towards D.H. Road – left turn from Chowrasta on D.H. Road South bound – Sakherbazaar crossing.

Similarly for return journey of all types of vehicles, those (Mentioned above) intend to reach Muchipara crossing from Sakher Bazaar crossing will avail D.H. Road – Right / left turn to proceed through Santosh Roy Road – take left turn from Sakherbazar / James Long Sarani crossing - James Long Sarani (North bound) – take right turn from James Long Sarani / Raja Ram Mohan Roy Road Crossing (towards east) – Raja Ram Mohan Roy Road (East bound) – Muchipara Crossing.

These will come into force with immediate effect and will continue for ninety (90) days from the date of commencement of work.
