TRAFFIC NOTIFICATIONS

Whereas it is necessary for preventing danger, obstruction or inconvenience to the public in connection with the INDIAN PREMIER LEAGUE TWENTY-20 CRICKET MATCH, 2025 AT EDEN GARDENS, KOLKATA on 22.03.2025, 03.04.2025, 06.04.2025, 21.04.2025, 26.04.2025, 04.05.2025, 07.05.2025, 23.05.2025 and 25.05.2025, I, Manoj Kumar Verma, Commissioner of Police, Kolkata, in exercise of powers vested upon me under Section 115, 117, 122 and 126 M V Act, 1988 and Section 62, 62(1b) of Calcutta Police Act./ 39, 39(1b) of Calcutta Suburban Police Act read with Rule No. 85, 86, 87, 88 and 93 of Rules for the Regulations of Traffic in Kolkata and its suburbs and under sub-section(1) of Section 4 of the West Bengal Traffic Regulations Act, 1965 (W B Act XV of 1965) read with Govt. of West Bengal Home (Transport) Department Order No. 7605-WT, dated the 20th July, 1965 and Govt. of West Bengal Transport Department Notification No. 3363-WT/3M-34/99, dated the 29th April, 1999, do hereby order that all classes of vehicles and all kinds of traffic including pedestrian traffic for the city of Kolkata shall be regulated in the manner prescribed below on the days of the matches -

1) Movement of all types of Goods Vehicles shall be temporarily restricted / suspended and / or diverted from the roads or road stretches at and around Eden Gardens and Maidan area on 22.03.2025, 03.04.2025, 21.04.2025, 26.04.2025, 07.05.2025, 23.05.2025 & 25.05.2025 from 16.00 hrs. till 01.00 hrs. (Next day) and on 06.04.2025 & 04.05.2025 from 12.00 hrs. till 21.00 hrs. or till dispersal of the crowd in addition to normal restriction, except those bound for Posta market from Howrah along St Georges Gate Road, Strand Road on those days. However, those vehicles will not be allowed to park, load / unload / or embark / disembark on those stretches of roads during the aforesaid times and dates.

Movements of all types of Goods Vehicles shall be restricted to ply in and around Victoria Memorial Hall, i.e. Portion of AJC Bose Road between D L Khan Road to Cathedral Road, Hospital Road, Queensway, Cathedral Road, Casuarina Avenue and Lovers Lane.

- 2) Kshudiram Bose Road (Auckland Road), North Brooke Avenue and Gostha Pal Sarani (Kingsway) will be closed to all types of vehicles on 22.03.2025, 03.04.2025, 21.04.2025, 26.04.2025, 07.05.2025, 23.05.2025 & 25.05.2025 from 16.00 hrs till 01.00 hours (Next day) and on 06.04.2025 & 04.05.2025 from 12.00 hrs. till 21.00 hrs. or till dispersal of crowd. High Court bound cars may be allowed to move along Esplanade Row West, instead of Auckland Road and North Brooke Avenue, as and when considered necessary by Traffic Police on duty.
- 3) Parking of vehicles will be prohibited on both sides of the following roads as and when considered necessary by the Traffic Police on duty:
 - a) Gostha Pal Sarani (Kingsway).
 - b) Kshudiram Bose Road (Auckland Road).
 - c) Govt. Place East.
 - d) Rani Rashmoni Avenue.
 - e) Old Court House Street.
 - f) Indira Gandhi Sarani (Red Road).
 - g) Guru Nanak Sarani (Mayo Road).
 - h) Dufferin Road.
- 4) Movement of All types of vehicles will be diverted on 22.03.2025, 03.04.2025, 21.04.2025, 26.04.2025, 07.05.2025, 23.05.2025 & 25.05.2025 from 16.00 hrs. till 01.00 hours (Next day) and on 06.04.2025 & 04.05.2025 from 12.00 hrs. till 21.00 hrs. as prescribed below:-
- a) Buses and Mini Buses coming from south Kolkata for BBD Bag area will be diverted (i) from R R Avenue towards Netaji Statue, Govt. Place East, Old Court House Street, B B D Bag and also (ii) from J L Nehru Road towards Bentinck Street, Mission Row, Mangoe Lane, B B D Bag, depending on the volume of traffic or as and when considered necessary by the Police on duty.

Similarly, Buses and Mini Buses from north and east Kolkata will be diverted (i) from Central Avenue towards Ganesh Ch. Avenue, Mangoe Lane, B B D Bag, (ii) from S N Banerjee Road towards R R Avenue, Govt. Place East, Old Court House Street, B B D Bag for westward journey and also (iii) from Old Court House Street towards Esplanade Row East, J L Nehru Road for southward journey as and when considered necessary by Police on duty.

b) Motorists from south Kolkata may avail A J C Bose Road, St. Georges Gate Road, Strand Road and find access to B B D Bag area through Kiran Sankar Roy Road towards Council House Street according to the direction of traffic police on duty.

Similarly, motorists from north and east Kolkata will enter B B D Bag area through B B Ganguly Street and also from S N Banerjee Road, R R Avenue, Govt. Place East, Old Court House Street etc. as directed by traffic police on duty.

- c) Howrah Bound Buses & Mini Buses coming from South and South West Kolkata along D H Road, Khidderpore Bridge Khidderpore Road will be diverted from Hastings crossing via St. Georges Gate Road Strand Road for their northward journey, as and when required.
- d) Howrah Bound Buses & Mini Buses coming from South and South West Kolkata along D H Road, Standle Road, Alipore Road Belvedere Road Zeerat Bridge will be diverted from Belvedere Road / AJC Bose Road crossing via AJC Bose Road AJC Ramp St. Georges Gate Road Strand Road for their northward journey, as and when required.
- e) Howrah Bound Buses & Mini Buses coming from South Kolkata along AJC Bose Road J L Nehru Road Mayo Road will be diverted from Dufferin Road / Mayo Road crossing via- Dufferin Road Khidderpore Road Ghorapath St Georges Gate Road Strand Road for their northward journey, as and when required.

f) NO PARKING SPACE WILL BE PROVIDED FOR TAXIES, PRIVATE BUSES, ETC. IN AND AROUND EDEN GARDENS.

- g) Bus stand at Band Stand and Auckland Road will be shifted to Kiran Shankar Roy Road and Esplanade Row East, Central Bus Terminus on the days of the matches.
- h) Vehicular traffic may also be diverted from any of the arterial and feeder roads by traffic police on duty as and when considered necessary in the interest of the public on the days.

These Notification will remain in force in addition to the other normal restrictions on the match days, which are not repugnant to above.
